



CODES FOR THE CLASSIFICATION OF DATA

IPONZ conforms to the World Intellectual Property Office (WIPO) standards for identifying key bibliographical data on Journals and some extracts for patents, trade marks and designs. Because these numbers are consistent in every country, they allow you to read important information from a patent even if you don't understand the language it's printed in.

The standard uses INID codes that tag specific key information. These INID codes are displayed as numbers in parentheses next to the information. ("INID" is an acronym for ICIREPAT (ICIREPAT - International Cooperation in Information Retrieval among Examining Patent Offices) Numbers for the Identification of Data).

INID codes vary between patents, trade marks and designs; and the codes that are used by IPONZ for each of these are listed in the three tables below:
